

### STEPS TO COMPLETE THE KHDA REGISTRATION PROCESS 2026-2027

Before the joining date of 24 August 2026, all admitted students must be registered on the KHDA platform, and their KHDA contract must be signed.

- KHDA Registration: To begin KHDA registration, please provide:
- Student: Passport copy and Emirates ID copy
- Both parents: Passport and Emirates ID copies
- Parent's email address and UAE phone numbers
- Transfer Certificate (TC) or School Leaving Certificate (mandatory)

Please send all documents to Mrs. Douiri Meriem, KHDA Office at school: khda.registration@aflec-fr.org

If the Emirates IDs are not yet issued, registration will start with passport copies and the Transfer Certificate. Once the Emirates IDs are issued, please send soft copies to update the KHDA system.

### • Transfer Certificates (TC)

A valid Transfer Certificate is required before a student can join the classroom. Without it, KHDA registration cannot be completed.

#### • Transfers within Dubai or UAE

**1. Within Dubai:** A KHDA Transfer Certificate is required (issued and attested by KHDA through the previous school or nursery).

Note: Nursery students must also provide a KHDA attested TC.

- **2. From other Emirates:** TC must be attested by the educational authority of that Emirate:
- Abu Dhabi: ADEK
- Sharjah: SPEA
- Ras Al Khaimah: RAKDOK
- Ajman, UAQ & Fujairah: Ministry of Education

## 3. Transfers from North America, Western Europe & Australia

A Transfer Certificate (TC) is required from **Grade 2 and above**.

The TC must be issued on the school's official letterhead and signed by the principal. **No attestation** is required.

4. Transfers from the Middle East, South & Central America, Asia, Russia & Former Russian States, Eastern Europe, Africa & New Zealand

A Transfer Certificate (TC) is required from **Grade 2 and above**, and it must be:

- a. Signed and stamped by the previous school
- b. Attested by the Ministry of Education in the country of origin
- c. Attested by the UAE Embassy/Consulate **and** the UAE Ministry of Foreign Affairs (MOFA)

### 5. Transfers from GCC Countries

A Transfer Certificate (TC) is required from **Grade 2 and above**.

The TC must be signed, stamped, and attested by the Ministry of Education of the respective GCC country.

N.B: Students enrolled in French curriculum schools (AEFE or MLF) must also comply with KHDA rules by providing a fully attested Transfer Certificate.
